2010 SUMMER CAMP SCHOLARSHIP PROGRAM**

The City of Boynton Beach offers 75% and 50% scholarships for summer camp programs through grant funding. **Funds are limited and scholarships are awarded on a first-come, first-served basis.**

CRITERIA

1. Must be a City resident (reside within the corporate city limits of Boynton Beach) and provide proof of residency via a current utility bill, tax bill or lease agreement.
2. Must meet income eligibility requirements (provide copy of last year's tax return and current check stubs for each adult in the household).

PROCESS

1. Complete the application.
2. Attach required documentation.
3. **Return completed application with all required documentation to Janice Phillips at the Civic Center, 128 E. Ocean Avenue, by March 1, 2010.** Applicant will receive an acknowledgement letter in the mail indicating eligibility for either a 75% or a 50% scholarship, approximately two weeks after receipt of your application.
4. Registration begins April 1 at Intracoastal Park Clubhouse, 2240 N. Federal Highway. When registering your child for one of the summer camp programs, you must bring the acceptance letter and pay your portion of the required camp registration fee. **If registration for camps does not occur on or before May 4, 2010, the scholarship will be rescinded.**
