In accordance with Section 110 of the City of the Boynton Beach Amendments to the Florida Building Code the request for a Special Structural Inspector, a Florida Registered Architect or Licensed Engineer, to perform the following mandatory or discretionary inspections, as outlined in Section 110 of the Florida Building Code. The Special/Threshold Inspector shall maintain progress inspection reports onsite during construction, submit to the jurisdiction on a weekly basis inspections reports, and provide a Certificate of Compliance after all work is complete to the Building Official before the final inspection as per Section 110 of the Florida Building Code.

Note: The Building Official shall determine which discretionary inspections are to be delegated.

Such plans shall also indicate in sufficient detail how the fire integrity will be maintained where required fire resistant floors intersect the exterior walls and where joints occur in required fire resistant construction assemblies.
